Image Reproduction Fee Schedule

The Historical Society of Harford County, Inc. has no in-house reproduction facilities. The fees, paid in advance, for reproducing images are based on the prevailing rates charged the Society plus handling and mailing charges.

Not all of our photographs in the collection have negatives; therefore, if photographic copies are required the fee will reflect the cost of producing the negative. All negatives are the property of the Society. If an order is placed that is not in our standard price list, contact will be made with the proper supplier, and a quote will be prepared and the Society will contact you. If you agree to the quoted price, the image will then be prepared.

Fees for individual/personal usage (i.e. decorations for home or office, illustrations for thesis/dissertations are based on reproduction charges.)

Scanned images for publication purposes can be put on a CD for \$8.00 for each image scanned.

Conditions of Publication

- 1. Permission is for ONE TIME USE ONLY. The Historical Society of Harford County requires prior permission, in writing, for each publication, re-publication, broadcast, display, or other public use of its collections or interiors. Possession of Historical Society photos does not constitute such permission. Permission must be requested in writing, and should be directed to the Archives, Genealogical or Library Chairman, depending on the nature of material requested. The Historical Society of Harford County retains all rights to the photos, and they must not be used for any purpose or in any way other than that listed on the permission form.
- Credit must be given to the Historical Society of Harford County as follows: Historical Society of Harford County, Inc. 143 N. Main Street Bel Air, MD 21014

The credit line should appear near the photo, or if the publication or display has a separate credit section, it must adequately indicate the location of the image within the publication or display.

- 3. Photographs may not be altered by cropping or other means without the permission of the Historical Society. In instances where a detail of an image is used, the caption must reflect this fact.
- 4. The Historical Society requests a gratis copy of each publication in which one or more of its images appears. Such publication should be mailed, immediately upon release, to the Society's headquarters.
- 5. The Historical Society of Harford County, Inc. reserves the right to refuse to grant permission and/or provide photo reproductions to publishers and individuals who have not complied with its policies. Also, if the original material requested is judged to be in fragile condition, photographic reproduction of this material may also be denied.
